

**RELEASE, WAIVER AND INDEMNITY AGREEMENT**

1. I, \_\_\_\_\_, (the “Releasor”) have read Greater Pittsburgh Gun Club’s Range Manual for rules and regulations and agree to conform to, abide by, and be bound by those rules and regulations as well as Greater Pittsburgh Gun Club’s posted rules and regulations. Failure to comply with such rules and regulations may result in the denial of my right to participate in activities at Greater Pittsburgh Gun Club and may result in my removal from the membership.

2. I am not prohibited from possessing and using firearms and I am in compliance with all federal, state and local firearm regulations.

3. I, the Releasor, intending to be legally bound, and in consideration of being permitted to participate in shooting activity at the Greater Pittsburgh Gun Club, also known as GPGC, LLC, (the “Activity”) do for myself, my spouse, my children, my heirs, executors, administrators, insurers and assigns, do hereby Release, Waive and forever Discharge the Greater Pittsburgh Gun Club, GPGC, LLC, William Drummond, and their respective officers, employees, representatives, affiliates, subsidiaries, insurers, successors and assigns (the “Releasees”), as well as the manufacturers and distributors or any equipment used in the Activity, from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or in equity, arising from or by means of any bodily injury or personal injuries, known or unknown, death or property damage resulting from, or to result from, my participation in the Activity, whether caused by the negligence of the Releasees or not.

4. I agree to indemnify and hold harmless the Releasees from any injury, loss, liability, damage or cost Releasees may incur due to my participation in the Activity, whether or not by the negligence of Releasees or otherwise.

5. I assume full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise while in or upon the property of Greater Pittsburgh Gun Club and GPGC, LLC., and while participating in any Activity.

6. I agree that this Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania, and that if any portion of this Agreement is held to be invalid, it is agreed that the balance shall continue in full legal force and effect.

7. This Release, Waiver and Indemnity Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania.

8. I hereby consent and agree to the exclusive personal jurisdiction and venue of the Court of Common Pleas of Washington County, Pennsylvania with respect to any legal action or proceeding arising out of or relating to the Activity. Each party hereby waives all rights it has, or which may hereafter arise, to contest such exclusive jurisdiction or venue in the Court of Common Pleas of Washington County, Pennsylvania.

9. I am of legal age and fully competent, and I have carefully read the foregoing Waiver, Release and Indemnity Agreement and I understand the contents of same. If I am not of legal age, my parents or legal guardian has fully read the foregoing Waiver, Release and Indemnity Agreement and understands it and understands that I am fully bound by their signature.
